Brief Description of Proposed Action (include purpose or need): The proposed zoning amendment to the MF “Multifamily Residence District” consists of three (3) parts: 1. Confirming that an “attached townhouse development” consisting of multiple buildings containing attached dwelling units is a permitted use in the MF District; 2. Confirming that area requirements, including setbacks, buffers and building coverage, applies to the entire property containing an attached townhouse development (rather than to each individual lot in the development); and 3. Modifying the maximum permitted building coverage applicable to a townhouse development from 10% to 18% of the area of the lot, except that the building coverage associated with any existing building determined to be of local historic significance that will be adaptively reused shall not be included in the calculation of building coverage hereunder, provided that, in no event shall the total building coverage of any attached townhouse development exceed 20% inclusive of the building coverage associated with such building of local historic significance, and the minimum separation between buildings from 60 feet to 15 feet, in order to better reflect the existing pattern of multifamily development in the Village.


